### **Business Development**

#### **Community Business Revitalization Program Los Angeles County Department of Economic Opportunity (213) 705-7597**

This project provides façade improvements to commercial buildings under the Districtwide Community Business Revitalization Program. The program targets businesses in low- and moderate-income unincorporated areas of the First District with emphasis in the Valinda and South San Gabriel area. Areas to be targeted include the following: Puente Valley and East Los Angeles.

#### **Grants and Technical Assistance for Small Businesses Pace Finance Corporation (213) 989-3144**

This project provides technical assistance to microbusinesses to help launch, stabilize, and grow a small business within the unincorporated areas of the Los Angeles County.

#### **Project Equity – East Los Angeles Workforce (323) 887-7122**

This program will provide technical assistance to small business owners who deliver goods and services to the predominantly low- and moderate-income residents of the unincorporated community of East Los Angeles to transition from single ownership to employee ownership in order to continue to create and preserve living wage jobs.

## **Job Training**
